## PRESS RELEASE FOR A BETTER URBAN FUTURE: UITP AND UN-HABITAT SIGN NEW MOU

## **BRUSSELS, 03 JUNE 2019**

Keeping up with our efforts to promote and foster the role of **urban mobility** and **public transport** in the global achievement of the Sustainable Development Goals, **UITP** is pleased to have signed a **Memorandum of Understanding** with **UN-Habitat**.

By entering into this MoU, UITP and <u>UN-Habitat</u> will **strengthen our cooperation** and **pursue joint efforts** to bring **support to urban areas** to develop mobility, with a focus on public transport.

Signed in the context of the <u>UN-Habitat Assembly</u>, both organisations have agreed to collaborate on the implementation of the New Urban Agenda and the 2030 Agenda for Sustainable Development.

UN-Habitat – The United Nations Human Settlement Programme - and UITP will jointly collaborate on advisory services, peer review, trainings and market dialogues to support sustainable urban mobility.

By doing so, will work together on **various mobility strategies** focused **towards decision makers** at relevant events, such as the World Urban Forum.

"UITP Members play a major role in advocating for sustainable urban mobility to achieve better quality of life. That outreach is elevated by working with key global players, such as UN-HABITAT. This MoU includes great collaboration projects and capacity building actions to transform our cities into engines of economic growth and development, leaving no one and no place behind. In the regard, we are delighted to announce our collaboration with <u>United Cities and Local Governments (UCLG)</u> on the creation of a new policy paper on *Mobility and the SDGs*, which aims at raising awareness about the Sustainable Development Goals and their relevance to public transport.

This paper focuses particularly on SDG 11 as the lynchpin of the localisation process of the SDGs, "a strategic attempt to include the local dimension and perspective in all phases of the policymaking process".

Recommendations include the integration of subnational perspectives into national SDG strategies and the need for the implementation of SDGs to be monitored and reported at the local level in order to improve the availability of data.
