In an increasingly urbanised world, inclusive green growth depends on efficient urban and non-urban mobility and adequate public transport infrastructure and services. If current mobility habits prevail – marked by the dominance of private motorised modes – urban congestion will gridlock cities, rapidly increasing greenhouse gas emissions and energy consumption. Increasing road space to accommodate greater car usage is not an option in many cities. Optimising the efficient use of existing road space is therefore a key principle to appraise the requirements of competing user groups. The integration of a mobility stakeholder into UITP is defined by its complementarity, support and synergy with other sustainable urban transport modes and in particular public transport. It should have a business model that is oriented towards sustainable mobility and help contain the number of vehicles in our cities. By joining UITP, members automatically adhere to this commitment.
