She/he shall contribute to global knowledge projects from the Asia Pacific perspective.

RESPONSIBILITIES

- 1. Manage the work, involvement and expectations of the Asia Pacific Organising Authorities platform (studies, reports, position papers, articles);
- Conduct research, knowledge development and data collection for research projects, under the direction of the Head of Asia Pacific Research. The projects are often co-funded by the Land Transport Authority of Singapore on topics of public transport, urban transport and sustainable mobility in the Asia Pacific Region conciliating the needs of the sector and the association and the expectations of Asia-Pacific members;
- 3. Support AP CTE innovative projects such as co-creation workshops and start-up challenges;
- 4. Manage and develop membership in the South East Asia region and deliver services (i.e. trainings and workshops) in line with the UITP Asia Pacific business plan;
- 5. Play an active role in facilitating external stakeholder relationship management relating to UITP AP CTE office in Singapore;
- 6. Ensure that knowledge content and research output in the Asia Pacific Region contributes to added value services to the direct benefits of the members and answers the priorities of the Integrated Global Work Programme;

- 7. Draft and contribute to Asia Pacific and global publications, including study reports, knowledge papers, policy briefs, newsletters, and other content;
- 8. Facilitate the sharing of content and information to different audiences (members, decision makers, internal stakeholders) using different communication means;
- 9. Lead public transport policy driven activities (ie: working groups, thematic events, etc) in Asia Pacific;
