### **UITP Publishes Position Paper on the Next Multiannual Financial Framework (MFF) 2028-2034**



**BRUSSELS, 5 June 2025**

As the European Union shapes its post-2027 budgetary architecture, UITP is calling for a bold and future-proof Multiannual Financial Framework (MFF) - that places urban, local and regional passenger transport at the heart of the EU's climate, competitiveness, and social justice goals.

With green investment needs in Europe reaching €1.2 trillion annually, UITP is stressing the need to shift the focus from mere spending to achieving clear outcomes: emission reductions, more public transport passengers, better accessibility, and economic inclusion.

The paper urges EU funding strategies to include not only traditional infrastructure investments but also to holistically support comprehensive mobility systems, integrating different transport modes, improving service quality, and enhancing passenger experience.

Modal shift is key and the need to prioritise efficient public transport and multimodal solutions over a car-centric approach.

Public transport remains the most space and energy efficient way to move large numbers of people, which is crucial for cleaner, healthier cities.

In this new paper, UITP outlines clear priorities:

- Create a permanent EU Climate, Energy, and Transport Investment Fund to strategically finance long-term, high-impact decarbonisation CAPEX investments in urban, regional, cross-border, and low-density area public transport.
- Reinforce urban mobility in National Single Plans

- Strengthen and simplify EU funding instruments like the Connecting Europe Facility, Horizon Europe, and Cohesion Funds to enhance accessibility for urban and local mobility projects.
- Dedicate EU Emissions Trading System (ETS) revenues and any forthcoming EU Green Bonds to sustainable mobility, prioritising zero- and low-carbon local transport projects aligned with EU taxonomy.
- Tackle transport poverty through MFF-linked inclusion measures.
